This announcement is made by Fameglow Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review and assessment of the information currently available to the Board, including the unaudited consolidated management accounts of the Group for the six months ended 30 September 2019 (the “**Period**”), the Group is expected to record a net loss of approximately HK\$4.5 million for the Period as compared to the net profit of approximately HK\$8.0 million (excluded non-recurring listing expenses) for the six months ended 30 September 2018.

The Board considers that the aforesaid turnaround from profit to loss position was primarily attributable to the increase in operating costs during the Period including staff costs, rental expenses, marketing and promotion expenses to support the Group’s business expansion and to gain market share. Moreover, the revenue from treatment services in recent months was affected due to weak market sentiment caused by the continuous social incidents in Hong Kong since late June 2019.

The Group is still in the process of finalising its unaudited consolidated financial results for the Period (the “**Interim Results**”). As such, this announcement is made solely on the basis of preliminary assessment by the Board with reference to the information currently available to the Board, which have not been audited or reviewed by the Company’s auditor and have not been reviewed by the audit committee of the Company, and may be subject to necessary adjustments. As such, the Interim Results may be different from the information contained in this announcement.

Shareholders and potential investors are advised to read carefully the Interim Results announcement, which is expected to be published on 12 November 2019.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
